#### OCTOBER 2023 BOARD MEETING HIGHLIGHTS

The Creekside Community Master Association Board meeting was held on October 11, 2023, at 6:00 PM at the Tennis Courts.

The Board approved Safeguard on Demand for community patrol services. Internet Wi-Fi Extenders was approved for all three (3) pool facilities. The Board agreed to reverse last months approval for the upgrade of the Tennis Court lights in the upper lot to save on association costs. Annual Tree Trimming and Removals was approved with Brightview Landscape as they matched a lower cost saving the association \$28k.

Please note, no other proposals were approved.

Homeowner Forum was held.

Executive Session was held immediately following the General Session and appropriate actions were taken.

The next Board meeting will be held on November 08, 2023, at the Tennis Courts at 6:00 PM.

## Community Pool Facilities Rules & Regulations Reminder

- Key FOBs are required to enter the pool gate. Please DO NOT let anyone into the pool area if they do not possess a Key FOB.
- Pool IDs are required to access all pool facilities.
- Each resident/family is entitled to no more than four (4) guests in the pool/spa/tennis court.
- All minors MUST be accompanied by a responsible adult (18 Years or
- The pool facility hours are from 6 AM 10 PM.

#### **Fact or Fiction**

The Creekside Community Master Association is NOT affiliated with any social media platforms or accounts. While we understand that these platforms can be useful for communication and community updates, it's important to note that any online presence purportedly representing the association is not officially recognized by the homeowner's association and we encourage residents to rely on verified sources.

In order for management to properly track and ensure a fast response time, we ask that homeowners use the AppFolio portal to submit maintenance requests, and/or architectural requests. You can also pay your assessments through AppFolio and if you have a smart device (which most of us do), you can download the app and do all of the above from the convenience of your phone. The portal allows us to ensure a prompt response.

Our community managers are out in the field and in meetings and emailing them directly may not result in a fast turnaround time; however, we have a team who is tasked with responding to all AppFolio requests and any emails sent to creeksideinfo@nextstepcommunities.co

Additionally, if you proceed to the AppFolio menu selection and click on Shared Documents, you will be directed to a list of subfolders that consist of the associations governing documents, architectural applications and guidelines. as well as meeting minutes and so much more!

If you would like to submit a complaint regarding a common area issue, homeowner issue, vendor issue, etc., we ask that homeowners complete the Member Report Form which can be found in the subfolder General Association Documents.

If you must email, please email creeksideinfo@nextstepcommunities.co m and a team member will respond within 48 business hours - if not sooner! If you need an immediate need, please call 800-562-3885. We may still ask you to submit a request through the portal, but we will handle it immediately.

We want to ensure you are receiving a timely response and have your needs addressed.
